Receipts for October totaled \$2,178.00 with \$1,331.44 going into the general fund.

<u>Assessor</u>

The exemption renewals are printed and ready to be mailed. The last few months we have seen houses selling for well over assessed value; \$37,000, \$75,000, \$125,000 and \$140,000 over assessed value. There are more but the ones mentioned are the highest.

<u>Highway</u>

The guys have been busy in the shop overhauling chainsaws, fixing a couple driveways on West Kendall Road. Maintenance on plow trucks included putting

the wings on; hydraulic cylinders. Tractor has been cleaned and put away for the winter. They have also completed the final mow of the cemeteries for the year; trimmed trees, chipped brush. Scott repaired our wood chipper. He did end up getting it to work but it is in bad shape as it is 14 years old.

<u>Water</u>

A leak was fixed in the Transit Road pit. A small sump pump leak was fixed in the Petersmith Road pit. A sump pump was replaced in the Fancher Road pit. There are a couple of meter-change appointments scheduled for this week but in light of recent events Louise is thinking we should cancel them.

The Board asked Louise to see if we could find out regarding water charge increases to us. Albion and Gaines will have no change. She did not hear back from the Village of Holley. Monroe County Water Authority said their meter charge will go from \$225.60 to \$271.50 and the water rate will go from \$3.72 to \$3.88/M.

The Board is in agreement to keep the meter change appointments as long as the homeowners are okay with it.

The town received a bill from MRB Group for fire flow testing for the Big Guys Campground property. Brief discussion regarding any bills incurred for this project. All in agreement that the project should incur the costs. Supervisor Sidonio reminded department heads to be aware when those bills come to us so the town can be reimbursed.

A public hearing on the proposed local law will take place at 7:00 p.m. on December 21^{st} before the regular Town Board meeting.

Brief discussion regarding the Joint Youth Recreation Commission. Councilman Hendel previously recommended that the contract be reduced from five years to two years and to cut the contributions from the municipalities and the school in half. It is also the responsibility of the municipalities and/or the school to collect money, pay bills, etc. The individual who has been doing this has done a great job but is retiring from the Village of Holley. Councilman Hendel said it is not a huge job but does take some time and there may be program funds that could go towards hiring someone for the job. That would be a decision for the Youth Commission.

Old Business

The County Planning Board needs a representative from the Town of Murray. This is something to think about and the vacancy can hopefully be filled at the organizational meeting in January.

Councilman Christ said that it is his understanding that special use permits are to be inspected/reviewed for compliance every two years. He was informed that this is not being done. Supervisor Sidonio said that moving forward, this can be addressed by our Code Enforcement Officer.

Councilman Christ also questioned that there are certain individuals that do not have special use permits that possibly should. Supervisor Sidonio stated that there are plenty of places in the town that need improvement and that our new Code Enforcement Officer will be reviewing everything. He is very qualified as he is licensed in code enforcement, fire inspection and soil and storm water inspection.
