RESOLUTION 2023-040

MURRAY TOWN BOARD RESOLUTION TO APPROVE THE AGRICULTURAL & FARMLAND PROTECTION PLAN

At a regular meeting of the Murray Town Board, held on August 21, 2023, the following resolution was moved, seconded and duly adopted by a unanimous roll-call vote:

WHEREAS,

1. The Murray Town Board has, after careful study, considered the proposed document entitled Town of Murray Agricultural & Farmland Protection Plan, which was prepared with financial assistance from the NYS Department of Agriculture & Markets; and
2. The Murray Town Board has considered comments made by the public at the Public Hearing held on August 2, 2023; and
3. The Murray Town Board has provided copies of the Plan to the Orleans County Agricultural & Farmland Protection Board, which approved the Plan on July 12, 2023; and
4. The Murray Town Board has carefully considered the impacts associated with approval of the Plan and finds that said Plan constitutes a suitable, logical and timely strategy for the support of agriculture and protection of farmland in the Town of Murray; and

5. The Town of Murray established an Agricultural Advisory Committee in its Right to Farm Law (Local Law No. 1 of 2001)
6. The Murray Town Board acknowledges and hereby gives public notice that official copies of the Town of Murray Agricultural & Farmland Protection Plan and all modifications thereof will be on file in the Office of the Murray Town Clerk.

NOW THEREFORE, BE IT RESOLVED, that

1. The document consisting of text, maps and charts entitled Town of Murray Agricultural & Farmland Protection Plan is hereby approved.
2. The Town Board hereby directs the Agricultural Advisory Committee to review the Plan at least annually and to assist with and monitor its implementation.

Councilman Bower is satisfied with our current bank and wouldn't be comfortable with it. Councilmen Rightmyer, Christopher and Christ are willing to listen.

Board would like more information regarding the grant for an electric car charging station before discussing this.

PUBLIC COMMENTS

Stacey Keon of West Brockville Road asked the status of public water on West Brockville Road. Supervisor stated that we are moving into the budget cycle and will be in discussions regarding that.

Mark Scarborough of Gulf Road seconded Ms. Keon's question as he is in need of the same.

Elaine Berg of Fancher Road asked why the live streaming is still not working correctly. The Town paid for this and each month it isn't corrected.

Kathy Case, former Election Commissioner said that the internet reception in the town garage needs to be improved in order for voting to take place there. It is a challenge for the election inspectors when they cannot get a connection.
