## Public Hearing on Preliminary Budget

Supervisor gave a brief budget overview. Tax rates for inside village are increasing from \$3.03 per thousand to \$3.23 per thousand. Rates for outside village are increasing from \$4.61 per thousand to \$4.81 per thousand, making it a 20¢ per thousand increase. The ambulance contract was a big hit on the budget. We are under the tax cap by \$2,039.11. As far as fund balance is concerned, we are in good shape. The water as a whole is making money, and projected earn \$74,000 but his concern is that 78% of that amount is attributed to just four districts.
