Murray Town Board Meeting

February 26, 2024

Meeting called to order at 7:00 p.m.

Pledge to the flag.

Motion by Berg, Seconded by Christopher approving the minutes of the January 22nd Town Board meeting as submitted Motion Carried

Supervisor Rightmyer addressed those present regarding rumors in respect to giving himself a 15% raise. Nothing could be further from the truth. Under the last administration, someone contacted our bookkeepers and had them remove the \$1,500 amount from the 'budget services' line on our 2024 Town budget. This \$1,500 has been part of the Supervisor's salary for many years. In light of this, at January's meeting, we simply re-established the \$1,500 amount on the 'budget services' line with funds coming from appropriated fund balance.

There has also been talk that the town must have an agricultural representative as a member of the planning board. After looking at our zoning ordinance, the town attorney said it is poorly worded and it is his interpretation that we do not need an agricultural representative on the planning board.

Town Clerk

Receipts for January totaled \$235.00 with \$163.16 going into the general fund.

Cindy received notice from the County Legislature that David Knapp has been appointed to the Orleans County Planning Board as the At-Large East representative.

The Legislature also appointed Scott Lang to the Orleans County Planning Board as the Town of Murray representative.

Assessor's Department

The office has been busy with ag. exemptions and sr. disability exemptions.

Highway and Water

There have been some flooding issues with the rain and thaw. Supervisor Rightmyer and Dirk went out and identified spots where ditching and/or pipe replacement is needed. The highway department cleaned up brush on Collucci Drive and are getting ready to ditch that also.

Salt consumption is right on target. The new truck has been ordered. They are more than a year out until it comes in. The 2024 pick up has been delivered. We have approval to be reimbursed for that.

Water continues to be stable. In the fourth quarter we had a big leak and did lose water, but knowing that loss, we are now staying pretty stable.

Public Comments

Sandy Shaw of the Community Free Library was present to inform the Board of ideas she has for community viewing of the eclipse.

She reminded all of the wine tasting that will take place on April 26th at the library. Tickets go on sale April 1st. She will bring some tickets to the Town Clerk's office for purchase by the public.

Justice Spada and Justice Passarell spoke to the Town Board regarding the plan for the Town to reduce the number of Justice's from two to one on January 1, 2025.

In August, 2022 both Judges presented a plan to the Town Board to reduce the number of Justices from two to one. Reasons for this were that the only other town with two justices is Albion but their caseload is 2.4 times larger than Murray's. Town courts of Ridgeway and Shelby are functioning with one judge and they have 1.7 and 1.4 times higher caseload than Murray. Their plan included Judge Spada not seeking re-election in 2024 and the board then appointing him to fill the remainder of Judge Passarell's term which will expire December 31, 2025.

Their proposed new plan moving forward is for Judge Spada to seek re-election in November 2024 for a term of four years. On January 2, 2026 he will resign effective May 31, 2026. This will give the town time to select a candidate for town justice and the candidate can attend NYS Town and Village Judicial training. Judge Spada will then mentor the new justice in town court and CAP court. The present court clerks would resign on May 31, 2026 also. Court clerks have many duties in a variety of areas. This new plan will ensure the new justice and court clerk will have the training needed.

New Business

RESOLUTION 2024-013

WHEREAS, New York State Town Law 60-a.2 authorizes the Town Board to reduce the number of Town Justices by the adoption of a resolution, subject to permissive referendum; and

WHEREAS, the Town Board has determined that it will be in the best interests of the Town to reduce to once justice; and

WHEREAS, the case load and amount of business handled in the Town Court of the Town of Murray is typical of those in similar towns with a single justice; and

NOW, THEREFORE BE IT RESOLVED as follows:

1. The Town of Murray will reduce the number of Town Justices from the current number of two (2) to one (1) effective January 1, 2025, upon the expiration of the term of office ending December 31, 2024, and
2. In accordance with the provisions of New York State Town Law 60-a.2, this Resolution is subject to a permissive referendum.

FURTHER BE IT RESOLVED that this resolution or a summary hereof shall be published in full in the official legal newspaper of the Town for such purposes, together with a notice of the Town Clerk.
