## **New Business**

### RESOLUTION 2024-20

At a meeting of the Town Board of the Town of Murray, duly held on May 29, 2024, Councilperson Christ moved adoption of the following resolution; Councilperson Bower seconded the motion:

BE IT RESOLVED, that the Town Board of the Town of Murray authorizes the Town of Murray Highway Superintendent to enter into the Right-of-Way Mowing Contract with New York State for the period of June 1, 2024 through October 30, 2024.

Upon being put to a vote, the resolution was unanimously adopted.

Brief discussions regarding a culvert replacement on Brockport Holley Road, and Deposit & Investment policy's that the auditor's suggested the Town adopt.

The Planning Board will be meeting to discuss overlay districts within the Town as we would like to encourage development.

## Old Business

Dirk has been working on the Holley-Murray water contract with the village.

Discussion regarding the proposed water line extension. The health department is fine with the proposal. We were able to add three more property owners for the extension which brought the bond repayment down to an acceptable level. Water sampling will be done at the six homes which will help bolster our case for the grant. Councilperson Elaine Berg stated that Supervisor Rightmyer has spent a tremendous amount of time on this project and has run into many road blocks. Legislator Fitzak stated that Congresswoman Tenney has grant money available for projects like this. Supervisor Rightmyer informed all that whatever amount of funds we receive will be taken off of the grant funds the Town will receive.
